

Eligibility

Al Aman Fund targets two different types of orphaned youth:

- 1. **Boarding orphans:** those who have resided in orphan care centers registered under the Ministry of Social Development throughout most or all of their childhood.
- 2. **Non-boarding orphans**: those living with a guardian or immediate relative under dire economic circumstances, and who are assisted by orphan support organizations registered under the Ministry of Social Development. Given that they meet the following criteria:

Non-Boarding Beneficiaries

General Rules:

- **1.**Preference is given to specializations required in the labor market.
- 2. The applicant must attend an interview with Al Aman's team to discuss the specializations offered and bring an acceptance notice from the academic body (university, community college, vocational training) and then complete the procedures.
- 3.If the applicant is unable to obtain admission to public universities, he can apply to obtain admission through the parallel system in public universities or private universities.
- 4.The Applicant must submit the grant application electronically and complete all the required documents, in addition to filling out the fund's case study form showing all the data and attaching all the required documents.
- 5. Those who succeed at a rate of 50% 65% are given one chance not to enroll in colleges.
- 6.If the first option is a diploma, the options available for the fields of study are only vocational and technical.
- 7.Students in care homes who have completed an intermediate diploma and met the admission and bridging conditions (according to the standards of the Ministry of Higher Education) may be accepted for the bachelor's level according to a decision from the Review and Audit Committee and approval from the General Manager.
- 8. Students of care homes who have not succeeded in high school are allowed to join



the vocational training program according to the specializations and training institutions accredited by Al Aman Fund.

- 9.A divorced or widowed orphan is allowed to apply for educational grants, provided that her age does not exceed 30 years.
- 10. The applicant must be financially unable to cover his educational expenses according to the procedures and forms determined by Al Aman Fund.

Conditions for obtaining the educational scholarship

- 1. The applicant must have resided in a Jordanian orphanage for at least two consecutive years, or three intermittent years.
- 2. The applicant's age when submitting the application must be between 18-24 years for males.
- 3. The applicant's age when submitting the application must be between 18-30 years for females.
- 4.The applicant must have a Jordanian secondary school certificate and obtain admission to the competition system or acceptance from a Jordanian university.
- 5. The applicant must have obtained admission in a Jordanian community college (Intermediate diploma degree).
- 6. Not to have obtained any educational scholarship from any other party.
- 7. The applicant should not have received support from any other party to cover educational expenses.
- 8.The applicant's monthly income should not exceed JOD 350, if there is an income.
- 9. Must not have been convicted of a misdemeanor or felony.
- 10. Must complete all required documents and sign all forms and documents required and approved by Al Aman Fund.



Needed documents

- 1.An official letter from the Ministry of Social Development proving the period of residence in the care home affiliated/registered with the Jordanian Ministry of Social Development for orphans residing in care homes.
- 2.A recent non-conviction certificate.
- 3.Transcript of high school grades (Tawjihi) certified by the Jordanian Ministry of Education, or a certificate proving the highest academic level the student has reached.
- 4. Acceptance notice from the academic body (university, community college, vocational training).
- 5. Case report form stamped by the nursing home/ministry.
- 6.Personal ID (if any).
- 7. Passport (if any).
- 8.Document/children of Jordanian women (if any).
- 9.6 recent personal photos.
- 10.A copy of the latest financial receipt from the institution where the student is studying.
- 11. Proof of a recent student (if any).
- 12. Detailed cumulative grade transcript (university).
- 13. Death certificate (mother, father) (if available).
- 14.A copy of the family book (all pages).
- 15.A copy of the birth certificate.
